EDITORIAL

DEAR MEMBERS, DEAR FRIENDS,

For CEEP, for Europe and for the world, 2016 has been a pivotal year. The year when the British people took the decision to exit the European Union. The year when citizens started to express a general scepticism towards international trade agreements, when Member States continued to disagree on the refugee crisis and when Turkey, EU's neighbour and partner, entered political turmoil. More than ever, uncertainty about the future reached new heights, with the European Union entering an existential crisis calling for an in-depth reflection on its nature and future.

We positioned ourselves early on in this reflection: our organisation is fully ready to take its responsibility, play its role, and further act as an intermediary between the EU and the citizens who have a relatively high level of trust in our members which are their national, regional and local public services and SGI providers. We can build upon this to positively communicate about the EU and bring back hope, a feeling of protection and fresh perspectives, eventually bringing back trust in the ability of decisionmakers to solve the current challenges. In this context, CEEP entered a new era, at a time when the key role of public services and SGIs in the EU must be defended and strengthened. In many Member States, public services' providers remain under pressure, regardless of the central place they are holding: CEEP represents 500.000 providers of key services, amongst which 25.000 are local public services' enterprises, which are essential to our economy and the welfare of the 500 million European citizens.

Providers of public services are also modern guarantors of a stable business location. Through our daily work, we strengthen Europe's competitiveness, support European diversity, provide for jobs and the infrastructure and assume responsibility for the citizens in Europe. Our members provide the stability necessary for growth and jobs' creation. They serve citizens, ensuring the provision of key services at the basis of our social model. As socially responsible employers, our members promotes strong industrial relations, convinced that sound and successful social dialogue is the basis for sustainable and long-lasting growth. At times when confrontation is everywhere, an association such as CEEP is all the more necessary.

CEEP is about building bridges between citizens and EU institutions, by ensuring constructive partnerships, and in its relationship with other stakeholders and institutions. Both for the EU and for CEEP, it is true that we can only inspire people if we involve them, if we get them to work together.

As already said, times are not easy. We should therefore build upon the work already done, whilst continuing to work hard to ensure public services and SGIs' employers and providers maintain their fundamental role in the EU social model.

WHAT IS CEEP?

CEEP, the European Centre of Employers and Enterprises providing Public Services and Services of General Interest, represents employers and enterprises providing services of general interest since 1961. Our members are organisations active in fields such as:

Modern public services and services of general interest (SGIs) support the fundamental goals of the EU, enabling business, social and territorial cohesion, economic and social solidarity and a better quality of life for all EU citizens.

PRESENT AT THE HEART OF THE EU

Together with BusinessEurope and the European Trade Union Confederation, CEEP is one of the three European general cross-industry social partners. CEEP is an actor in the European social dialogue, having a voice at the highest-level, at both bipartite (negotiating with trade unions) and tripartite (with social partners and representatives of the EU institutions).

LOBBYING FOR PUBLIC SERVICES

CEEP represents the interests of its members before the European institutions. It regularly lobbies the European Commission, as well as the European Council and the European Parliament, to have an impact on any legislative proposal affecting services of general interest and their place in the internal market.

ADVOCATING THE IMPORTANCE OF

PUBLIC SERVICES IN EUROPE

CEEP also carries out projects promoting the importance of modern public services in Europe. Whether supported by the European Commission or carried out independently, those projects intend to shed a new light on services of general interest, their modernisation and their central role in citizens' lives.



2016 IN REVIEW

A NEW PRESIDENT FOR CEEP

On 8 June 2016, CEEP General Assembly unanimously elected Katherina Reiche as CEEP President. Ms Reiche is Chief Executive Officer of the German Association of Local Utilities (VKU) and President of CEEP German section.

Ms Reiche has an extensive knowledge of national and EU politics, as former German Parliamentary State Secretary at the Federal Ministry for the Environment, Nature Conservation and Nuclear Safety from 2009 to 2013 and at the Federal Ministry of Transport and Digital Infrastructure from 2013 to 2015. During her political carrier and as a leading figure for German public services, she developed a personalized approach to policy-making, which she presented to CEEP General Assembly: "My vision of policy making – and with it also my vision of presiding an association like CEEP – is one of partnership, commitment and a culture shaped by open discussions".

Ms Reiche took over CEEP presidency from Hans-Joachim Reck who was CEEP President from 2011 until 2016. She will work in close cooperation with the other members of the CEEP Presidential team, Vice-Presidents Milena Angelova (BICA, BG), Filippo Brandolini (UTILITALIA, IT) and Tom Beattie (CEEP UK).





TRANSVERSAL PRIORITIES

In its Work Programme, CEEP identified a series of key corporate transversal priorities for 2016. In line with the main issues addressed by the European institutions, those priorities helped to ensure a better coordination of the actions, and an increased coherence in the positions defended. Four main transversal priorities were tackled, with each of the three boards playing an active role in the process.

BETTER REGULATION & REFIT PLATFORM

Represented by CEEP General Secretary Valeria Ronzitti, CEEP is now an active and central player in the REFIT Platform. The REFIT Platform was set up by the May 2015 Better Regulation Communication to advise the Commission on how to make EU regulation more efficient and effective while reducing burden and without undermining policy objectives.

It consists of a Stakeholder group, with 18 members and two representatives from the European Economic and Social Committee and the Committee of the Regions, and a Government group, with one high-level expert from each of the EU's 28 Member States. The members of the Stakeholder group were selected through a public call for applications and are appointed until 31 October 2019.

The REFIT Platform is chaired by European Commission First Vice-President Frans Timmermans.

Platform members consider suggestions made by citizens and stakeholders via the online form 'Lighten the load ', assess the merits of these contributions and consider proposing follow-up to the Commission.

In this context, CEEP is a key player, bringing to the table evidenced-based arguments and best practices. As such, CEEP contributed to the REFIT Platform recommendations on issues such as 'Competition - State Aid broadband', 'Competition - Conflicting definitions', 'ePrivacy', 'VAT information Portal', 'Standard VAT declaration' or 'Intra Community Trade'.

For the good implementation of the Better Regulation agenda, CEEP has pushed for 4 priorities to be taken into account:

- Increasing the transparency in the EU decision-making process, such as the trilogue;
- Striking the right balance between evidence-based and democratic decision-making, including by better taking into account regional and local impacts;
- Proposing more effective public consultations procedures, improving factors such as timing, intelligible drafting and transparency on how the results are taken into account;
- Simplifying existing legislation to the benefit of the modernisation of SGEIs in Europe.



DIGITALISATION OF PUBLIC SERVICES

Another key achievement of 2016 was the creation of a transversal working group on digitalisation, made up of digital experts from CEEP member enterprises and organisations. The working group met three times in Brussels, with the aim to:

- Showcase how digitalisation can support the modernisation of public services;
- Set up a platform for providers of public services from different sectors and national realities to exchange digital practices.

The working group on digitalisation contributed to placing CEEP at the heart of the discussions on the digital transformation and the Digital Single Market. Besides producing a CEEP Opinion approved during the statutory meetings in May, the working group published a booklet of best practices underlining the importance of digital tools in the provision of modern, efficient and effective public services.

The contribution of CEEP to the debate was completed with a final conference organised jointly with EuroChambres, with the participation of European Commission Vice-President Andrus Ansip, on 14 December 2016. The

event "Creating Inclusive Digital Eco-systems" gathered representatives of providers of SGIs and public services, chambers of commerce & industry, IT-specialists from a broad range of sectors and various other stakeholders. The event highlighted the need for digital ecosystems that are inclusive of citizens, public services, big businesses, SMEs and civil society.

In her introductory remarks, CEEP President, Ms Reiche, pleaded for a digital transformation including providers of services of general interest. "In the digital age, public service providers undertake essential initiatives about infrastructures that are indispensable to the society and essential for the entire economy: without rapid broadband coverage, there can be no digitalisation of business and society. Without reliable and intelligent energy supply, there can be no progress in industrial production and no security of supply. Without protection of water, there is no guarantee of essential services' provision and no supply and disposal in the area. The protection of critical infrastructures and cybersecurity are also taken very seriously by public service providers", said President Reiche.





INTEGRATION OF REFUGEES

The refugee crisis shaped 2016. CEEP supported throughout 2016 all efforts towards a pragmatic and united European solution, able to restore a fully functioning Schengen space while respecting international law principles. Public services' contribution in this process is key when it comes to the INTEGRATION, both in the society via the provision of essential public services such as housing, healthcare or water provision, but also into the labour market, via appropriate testing and screening of the skills and competences of incoming refugees, setting up educational courses. All these initiatives will create new recruitment opportunities which are vital for public services, where almost 30% of the workforce is over 50 years old.

CEEP reached out to the European Economic and Social Partners, and signed a joint letter on the Refugee Crisis with the ETUC, BusinessEurope, UEAPME and EuroChambres. The letter was presented to EU decision-makers (including Jean-Claude Juncker, European Commission President, and Donald Tusk, European Council President) at the Tripartite Social Summit in March 2016.

Finally, CEEP is an active player in the Labour Integration Project, jointly started in 2016 with the ETUC. The project is meant to set an enabling environment for successful integration strategies of asylum-seekers and refugees in the Labour market, to promote programmes for labour market inclusion tailored on the skills, knowledge and capacities of the newly arrived in the EU, comprising individuals under international protection, including refugees and considering those needs of the labour market, businesses, chambers of industry and commerce, trade unions and migrants' associations.

The project promotes multi-layered integration paths (from welcoming actions, language training to labour market activism). Moving from theory to practice, the action is based on 4 national pilot actions that can bring benefits to third-country nationals in the short term, as they are directly involved in the pilot actions and in the long-term as they will be the first beneficiaries of increased capacity of the project partners to provide assistance for the integration of asylum-seekers and refugees.





CEEP CSR Label 2016

On 14 November 2016, 25 enterprises providing public services and services of general interest were awarded the CEEP CSR Label. The awarding ceremony was held at the Caisse des Dépôts et Consignations (member of CEEP France) in Paris, and organised with CEEP France. A compendium of best practices and enterprises awarded was also circulated on this occasion.

"This label demonstrates that public services' providers in Europe do more than fulfil their services. They are also particularly conscious and active when it comes to positively impacting the society and the environment," said Valeria Ronzitti, CEEP General Secretary.

Pascal Bolo, President of CEEP France, also emphasised the importance of CSR for public services' enterprises and organisations. "CSR is part of their DNA, as public services' enterprises and organisations combine the private interests and management practices and the values of the public. They answer the call for modernity and efficiency with a positive vision, favouring long-term views and perspectives and not only looking for short-term benefits. Those enterprises also primarily use local resources and contribute to jobs' creation."

Corporate social responsibility is a key element for the management of public services. For this reason, in 2008, CEEP created the CEEP-CSR Label in 2008. It was created to answer the need of enterprises providing public services to be recognised for their activities in the field of CSR, without a label dedicated to public services' providers.

RELAUNCH OF SOCIAL DIALOGUE

QUADRIPARTITE STATEMENT ON THE RELAUNCH OF SOCIAL DIALOGUE

The European Social Partners initiated in 2015 the process of signing with the European institutions a tripartite statement featuring renewed actions and commitments to support social dialogue in Europe and in Member States. This process was concluded on 27 June 2016, with the official signing ceremony for the quadripartite statement on "a new Start for Social Dialogue", together with the European Commission, the Netherlands Presidency of the Council, CEEP, BUSINESSEUROPE, UEAPME and the ETUC.

On top of this quadripartite statement, EU social partners signed in July 2016 a joint statement on a new start for a

strong social dialogue, emphasising that social dialogue forms part of the European social model and is a crucial factor for a well-functioning social market economy. It also underlines that social dialogue implies industrial relations' models in which social partners can autonomously exercise their practices of collective bargaining and employee participation. Whilst recognising that social dialogue arrangements and processes vary from one Member State to another (reflecting the countries' different histories and economic/political situations), in all cases the role of social partners should be promoted.

IMPLEMENTATION OF THE SOCIAL PARTNERS' WORK PROGRAMME 2015-2017

Together with the EU cross-industry social partners (ETUC, BUSINESSEUROPE and UEAPME), CEEP made progress in 2016 to implement the Social Partners' Work Programme 2015-2017 on the following issues:

FOSTERING ACTIVE-AGEING AND AN INTER-GENERATIONAL APPROACH

In their work programme, social partners committed to preparing an autonomous framework agreement of "Fostering active-ageing and an intergenerational approach". This work started with a fact-finding seminar on 9 February 2016, and was followed by formal negotiations between trade unions and employers' organisations.

CEEP delegation discussed with its counterpart organisations for 9 months, and an agreement on a final text was reached in December, with the ratification by the

members of each social partners' organisations early 2017. The agreement is designed to ensure a healthy, safe and productive working environment and work organisation to enable workers of all ages to remain in work until legal retirement age. It will facilitate the transfer of knowledge and experience between generations at the workplace whilst considering the changing national demographic and labour market realities.

PROMOTING BETTER RECONCILIATION OF WORK, PRIVATE AND FAMILY LIFE AND GENDER EQUALITY, AND REDUCING THE GENDER GAP

The EU cross-industry social partners had planned several activities in their work-programme on "promoting better reconciliation of work, private and family life and gender equality and to reduce the gender gap". However, this bipartite agenda was momentarily postponed since the European Commission initiated a two-stage social partners' consultation on work-life balance, with the possibility to produce new legislative and non-legislative

instruments. CEEP responded to the consultation, after in-depth consultation of its members.

Despite CEEP's will to engage in negotiations with social partners, the consultation of the different organisations resulted in a non-negotiation between the EU social partners which automatically gave back to the European Commission the responsibility to pursue its own agenda on work-life balance.

INVESTMENT PACKAGE AND STRENGTHENING THE INDUSTRIAL BASE IN EUROPE

Following a year 2015 during which investment was at the forefront of the EU economic relaunch, 2016 brought the first outcome of this renewed focus. CEEP was involved in the discussions at all levels, taking part both in the Tripartite Social Summit for Growth and Employment and in the Macro-Economic Dialogue and agreeing with social partners on the need to anchor investments at the heart of EU macro-economic policies.

CEEP also supported the creation of a High-Level Task-Force on Social Infrastructure, launched in February 2017 under the chairmanship of Prof. Romano Prodi, also taking part in the debate held by the European Parliament Intergroup on Long-term Investment.

SKILL NEEDS IN DIGITAL ECONOMY

EU social partners initiated the joint work on digitalisation in 2016. Besides the working group on digitalisation, CEEP played a key role in supporting a joint statement of the EU social partners on digitalisation, emphasising that "digital skills should be a key priority in the upcoming EU skills agenda". This joint statement, was signed by the European cross-industry social partners in March 2016

and was presented to European Commission Jean-Claude Juncker and Council President Donald Tusk during the Tripartite Social Summit of 16 March 2016. The statement initiated new EU social partners' activities and set the basis for a future seminar in 2017 on the analysis of the impact of digitalisation on labour markets.and labour market realities.

ACTIVE LABOUR MARKET POLICIES

To further reflect on the effectiveness and quality of EU active labour market policies, CEEP and the EU social partners exchanged extensively in various fora, such as the Employment Committee of the Council, during

the sessions of the Social Dialogue Committee and in the context of the EU Semester. A first early axis on which social partners worked was the reflection on the integration of benchmarks for the Pillar of Social Rights.

FOSTERING APPRENTICESHIPS TO INCREASE YOUTH EMPLOYMENT

Member States' representatives and EU social partners (employers and trade unions - CEEP, ETUC, BusinessEurope and UEAPME) agreed on an Opinion of the Advisory Committee on vocational training (ACVT) "A Shared Vision for Quality and Effective Apprenticeships and Work-based Learning, which will be addressed to the European Commission."

Also, on 26 and 27 May, CEEP, together with the EU social partners, organised a joint conference entitled "Towards a shared vision of apprenticeships", as a part of the project

on apprenticeship undertaken in the EU social dialogue programme of integrated projects 2014-2016. This conference took place further to the individual projects that were conducted by the cross-industry employers' organisations on the cost-effectiveness of apprenticeship schemes and by ETUC on a quality framework for apprenticeships. The purpose of this event was to discuss the outcomes of each project and to identify possible areas for joint messages and/or future cooperation.



COMMITTING TO PROMOTE CAPACITY-BUILDING AND BETTER IMPLEMENTATION

OUTCOMES

CEEP and the EU Social Partners also pursued their efforts to reinforce the capacity building of social partner organisations at national level as well as the implementation of their autonomous framework agreements.

They organised together a joint Conference on "Promoting and reinforcing the EU social dialogue" on 5 & 6 July 2016. This conference was an opportunity to take stock of recent developments and to further discuss the quadripartite statement on a New Start for a Strong Social Dialogue. It also built upon the findings of the two-year integrated project on reinforcing EU social dialogue for the period 2014-2016.

The key objectives of the conference were to promote and further push the ongoing discussion on the quadripartite statement on a New Start on Social Dialogue and to follow up the work undertaken by the European social partners on promoting and supporting the social dialogue.

The conference gave EU and national social partners the opportunity to discuss and review the main challenges they face for an effective EU social dialogue, including capacity building and the role of social partners in economic governance.

ACTIVITIES WITH THE EMPLOYMENT COMMITTEE (EMCO) OF THE EPSCO COUNCIL

In October 2016, the EMCO (Employment Committee of the Council), of which CEEP is an active member, looked at the involvement of social partners in the European Semester, and invited national and European social partners to an interesting and fruitful discussion.

The overall aim of the review was to assess the state of play of the involvement of social partners in the EU Semester at national level, in line with Employment Guideline 7: "In line with national practices, and in order to improve the functioning and effectiveness of social dialogue at

national level, Member States should closely involve national parliaments and social partners in the design and implementation of relevant reforms and policies."

This review presented the opportunity for several CEEP members to exchange directly with their government representatives on the reality of their involvement in the European Semester, discussing both format and content. We will pursue this exercise in 2017 and further refine the practice.

REPRESENTING PUBLIC SERVICES AT EU LEVEL

TOWARDS AN INCLUSIVE EU SME DEFINITION

Initiated in 2015, CEEP continued to push forward the reflection on the impacts of the EU SME Definition on the provision of public services. Indeed, the current EU legal definition of SMEs (Commission Recommendation 2003/361/EC of 6 May 2003) excludes most local public enterprises from its scope because it excludes enterprises with a public ownership of more than 25%. As the SME definition is widely used both in European and national legislation, as well as in EU financing programmes, it unnecessarily discriminates local public enterprises for the very nature of their ownership structure.

CEEP Public Services Board started its lobby effort on this issue in 2015 by circulating a questionnaire to stakeholders impacted by the issue, as well as through an independent study whose results were presented at the November 2015 Public Services Board meeting. More deliverables were produced on the topic including a CEEP Opinion "For an Inclusive EU SME Policy" calling for an amendment to the European SME definition to guarantee equal treatment for all types of SMEs irrespectively of their type of ownership.

PRESERVING PUBLIC SERVICES IN TRADE AGREEMENTS

CEEP pursued in 2016 its efforts on trade agreements (TTIP, CETA, TiSA). Joining forces with the ETUC, the Social Platform and EPSU, CEEP penned a joint statement on 3 February 2016, "TiSA: Safeguard of Public Services Set as Red Line in EU Trade Agreements", following the adoption of the European Parliament resolution on TiSA.

CEEP also issued an Opinion on trade agreements, supporting a coherent implementation of the EU's trade strategy. As free trade agreements are an opportunity

to set worldwide standards to support sustainable development, CEEP calls for safeguarding subsidiarity and the essential role played by services of general interest (SGIs) and the social economy. The organisation also calls for more legal certainty over the safeguard of the provision of SGIs in international trade agreements, and to include standard clauses to fully preserve the discretionary power of national, regional and local authorities to decide how to provide, organise, finance and commission SGIs.

CONSOLIDATING THE PUBLIC SERVICES' EMPLOYERS' FORUM

The Public Services' Employers' Forum continued its work to further promote the activities of employers of public services at EU level, with a joint declaration on digitalisation, where public services' employers expressed their priorities, calling for:

- an inclusive approach and the involvement of public services' employers in the design and the implementation of the Digital Single Market Strategy.
- a level playing field allowing all actors to fully take advantage of digitalisation in a fair regulatory environment.
- an active dialogue with social partners, when it comes to monitoring the impact of digitalisation on jobs and working conditions, including new forms of employment, and its impact on work-life balance.
- a comprehensive approach on digital skills and training as part of the Digital Single Market Strategy and the upcoming New Skills Agenda for Europe.

PROJECTS

Training and Promotion of Social dialogue measures for public services

Social dialogue is a key tool for ensuring the smooth functioning of labour markets. It is also powerful for finding effective ways of establishing and maintaining social cohesion and improving governance. However, the visibility of social dialogue at EU level and its impact on national and European policies need to be better promoted, especially in Member States which joined the EU in 2004, 2007 and 2012.

Raising awareness about the importance and potential of social dialogue is a key priority for the EU social partners. In this context, CEEP represents the voice of public services and SGI' employers in the European Union, influencing the European policy and legislation and having an impact on industrial relations at European, national and local level. With the support of the European Trade Union Confederation (ETUC), CEEP carried out a project aimed at following up the social partners' commitments toward capacity building, renewed through the signature of a quadripartite statement on A New Start for Social Dialogue.

To promote a better understanding of the European social dialogue in a selected number of key public service areas (healthcare, education, public administration, road transport), CEEP and ETUC launched a series of training and informative seminars in Brussels and Prague in 2015, bringing together employer and trade union representatives. The training focused mainly on two results of the EU social dialogue: The Framework Agreement on Inclusive Labour Markets and the Framework of Actions on Youth Employment, and focused on the 12 Member States which joined the EU in 2004 and 2007.

Research carried out in the framework of the project also showed that information available on the current situation of social dialogue in public services at national, regional and local level, is scarce. This is due to the complexity and diversity of public services' models of organisation across Europe, with significant differences in industrial relation systems. Therefore, the implementation of the EU Social Partners' instruments is often challenging, and in some cases, does not even occur.

SOCIAL SERVICES IN EUROPEAN CROSS-INDUSTRY SOCIAL DIALOGUE: TOWARDS A STRONG AND DEEPER INVOLVEMENT

CEEP, with the support of SALAR, SWO, UNISOC, UZS and HOSPEEM, conducted a project aimed at improving the involvement of social services' employers in EU cross-industry social dialogue. The project intended to identify existing social services' structures in 14 selected EU Member States and the conditions for their active involvement at the cross-industry level of social dialogue.

The project builds up on important aspects of the previous CEEP project: "Mapping of the Public Services." It was designed to provide additional and specific data on structural, procedural and statistical variables on social services. The data collected focused on social services, including both public and private not-for-profit service providers. Whilst mapping social dialogue actors and structures, the project partners targeted employers' organisations active in social dialogue.

To that end, social services are defined as services with a distinct social objective. By delivering essential services, they are crucial for the well-being of citizens, and highly contribute to the social and territorial cohesion of the EU. Their main aim is to achieve wider social, environmental or community objectives. To define social services, the project used the NACE 2007 classification, with a wide approach to what they encompass – hospitals and care, museums, libraries, arts, sports and amusement, and other social services.

The objective of the project was to strengthen the interest and participation of social services' providers in the European cross-industry social dialogue. It was important to identify the organisations active at national level, as well as their common challenges, to offer solutions through representation at EU level.
